**Peaceful Pastures Donkey Rescue rehabilitates rescued donkeys by providing medical, nutritional, and behavioral support prior to adopting them to carefully vetted loving homes. We completed rehabilitation with many of the rescues this year and were able to adopt out 106 equines in 2023. To date, one of our adopted donkeys was returned and remains here, and all the others adopted are happy and healthy in their new homes.**

**Peaceful Pastures Donkey Rescue takes in abused, neglected, malnourished and otherwise unwanted donkeys. Our donkeys come from outbidding traders and kill buyers at auctions, law enforcement seizures, and surrenders. Some surrenders are obtained from a kill pen and are ill and severely abused. Others are from homes who could not care for them or where they displayed behavioral problems. In 2023, we rescued and accepted a total of 196 new equines in need into the rescue.**

**Peaceful Pastures Donkey Rescue hosts multiple annual events and frequent tours of the rescue, attends public events, and has a growing presence on social media. Our goal is to educate the public about the mistreatment and cruelty experienced by donkeys. We educated roughly 800 people on site about the mistreatment of donkeys. We attended 6 public appearances and educated diverse groups about the plight of the donkey in the trader industry. Our social media platforms provide ample education, including Facebook, Instagram and You Tube. As of this writing, Facebook reports that we reached 2.1 million people in the last 90 days. We intend to continue to educate through a variety of venues in order to reach all generations.**
